MEMORANDUM OF DECISION

O'Naturals, Inc., appeals from a judgment of the District Court (Augusta, *Dobson, J.*), entered after a disclosure hearing, ordering O'Naturals to turn over monthly franchisee payments to NorthCenter FoodService, LLC, a corporation that obtained a money judgment against O'Naturals. Contrary to O'Naturals' arguments, in the absence of a request for findings of fact, the record supports the court's implicit finding that O'Naturals owned nonexempt assets, *see* 14 M.R.S. § 3131(1) (2012); M.R. Civ. P. 52(a); *Seacoast RV, Inc. v. Sawdran, LLC*, 2013 ME 6, ¶ 4, 58 A.3d 1135, and the court acted in accordance with the disclosure statutes in granting NorthCenter's request for a turnover order, *see* 14 M.R.S. §§ 3120, 3125, 3131(1) (2012); *Spottiswoode v. Levine*, 2001 ME 54, ¶¶ 5-6, 769 A.2d 849.
