MEMORANDUM OF DECISION

Ronald S. LaRoche appeals from a judgment of foreclosure entered by the District Court (Lewiston, *MG Kennedy, J.*) in favor of OneWest Bank, FSB (OWB), following a bench trial. The judgment predated the issuance of our opinion in *Bank of America, N.A. v. Greenleaf*, 2014 ME 89, 96 A.3d 700. Pursuant to our holding in that case, OWB is not entitled to judgment because the evidence establishes as a matter of law that it lacked standing to foreclose on the mortgaged premises. *Id.* ¶¶ 12-17. Because we vacate the judgment on that basis, we do not reach LaRoche's argument that the notice of default did not satisfy the requirements of 14 M.R.S. § 6111 (2014).

Judgment vacated. Remanded for dismissal of the complaint.
