MEMORANDUM OF DECISION

Lynn M. (Chasse) DiPietro appeals from a judgment of the District Court (Fort Kent, *Soucy, J.*) denying her motion to modify and granting Gary Chasse's motion to modify the parties' divorce judgment to award primary residence of the parties' two children to Chasse. Because DiPietro has not provided an adequate record for appellate review, we assume that the record supports the facts found by the court. *Hamilton v. Hamilton*, 2009 ME 83, ¶ 13 n.3, 976 A.2d 924. Contrary to DiPietro's contentions, the court did not commit legal error in its assessment of the statutory best interest factors, and the children's need for stability and continuity, in determining that awarding primary residence to Chasse is in the children's best interest. See 19-A M.R.S. § 1653(3) (2015); *Light v. D'Amato*, 2014 ME 134, ¶¶ 21-24, 105 A.3d 447; *Nadeau v. Nadeau*, 2008 ME 147, ¶ 35, 957 A.2d 108.
