## MEMORANDUM OF DECISION

After a bench trial, the court (Washington County, *Stewart, J.*) found that Aaron Getchell, a thirty-five-year-old man, sent more than twenty unsolicited and unconsented-to Facebook messages, including the messages, "You wanna see a dick pic?" and, "Its [sic] Big......" to a fifteen-year-old girl.<sup>1</sup> Then, after receiving no indication from the girl that she was receptive to this communication, Getchell sent her a picture of his penis.

Getchell challenges the ensuing conviction of harassment by telephone or by electronic communication device (Class E), 17-A M.R.S. § 506(1)(A) (2017),<sup>2</sup> entered by the court, asserting that his constitutional rights to engage in that

behavior were violated. *See* 15 M.R.S. § 2115 (2018); M.R. App. P. 2B(b)(1). Finding no factual or legal error, we affirm Getchell's conviction. *See* 17-A M.R.S. § 34(1), (4)(F) (2018); *Childs v. Ballou*, 2016 ME 142, ¶¶ 18-19, 148 A.3d 291; *State v. McLaughlin*, 2002 ME 55, ¶ 9, 794 A.2d 69; *State v. Hills*, 574 A.2d 1357, 1358 (Me. 1990); *State v. Maine State Troopers Ass'n*, 491 A.2d 538, 543 (Me. 1985); *State v. Gray*, 440 A.2d 1062, 1064 (Me. 1982); *Union Mut. Life Ins. Co. v. Emerson*, 345 A.2d 504, 507 (Me. 1975).
