MEMORANDUM OF DECISION

Claudia G. Viles appeals from a summary judgment entered by the Superior Court (Somerset County, *Mullen, D.C.J.*) in favor of the Town of Anson on the Town's claim for conversion against Viles.¹ Contrary to Viles's contentions, the court did not err when it concluded that the summary judgment record conclusively established, as a matter of law, Viles's liability for civil conversion. *See* M.R. Civ. P. 56(c), (e), (h); M.R. Evid. 803(22), 902(4), 1005; *Brooks v. Lemieux*, 2017 ME 55, ¶ 9, 157 A.3d 798; *Gray v. TD Bank, N.A.*, 2012 ME 83, ¶ 10, 45 A.3d 735; *Hanover Ins. Co. v. Hayward*, 464 A.2d 156, 159-61 (Me. 1983); Restatement (Second) of Judgments § 85(2)(a) & cmt. e (Am. Law Inst. 1982). Nor did the court err when it determined that the summary judgment record also established, as a matter of law, the amount of damages awarded in the Town's favor. *See* M.R. Civ. P. 8(c), 56(c), (h); *State v. Gagne*, 2019 ME 7, ¶ 23, 199 A.3d 1179; *Beal v. Allstate Ins. Co.*, 2010 ME 20, ¶¶ 14, 17, 989 A.2d 733; *Inniss v. Methot Buick-Opel, Inc.*, 506 A.2d 212, 217-18

¹ For reasons that are not clear to us, the Town sought this judgment despite the fact that a separate civil judgment already exists, requiring Viles to pay the Town \$566,257.65 as compensation for the injury associated with this case. *See* 17-A M.R.S. § 1330-C (2018).
