MEMORANDUM OF DECISION

U.S. Bank Trust, N.A., as Trustee for the LSF9 Master Participation Trust, appeals from a judgment of the Superior Court (York County, O'Neil, J.) dismissing its declaratory judgment complaint against Evest Lending, Inc., and several parties in interest for failure to state a claim upon which relief could be granted. See M.R. Civ. P. 12(b)(6). Contrary to U.S. Bank's contentions, (1) the court did not abuse its discretion in vacating an earlier dismissal by the court (Douglas, J.) upon finding insufficient proof that U.S. Bank's first motion to dismiss had been served on party in interest Michele Leo, see M.R. Civ. P. 5(b), (d) (Tower 2017); M.R. Civ. P. 60(b); Haskell v. Haskell, 2017 ME 91, ¶ 12, 160 A.3d 1176; (2) the court (O'Neil, J.) did not abuse its discretion in denying U.S. Bank's subsequently filed motion to voluntarily dismiss without prejudice, see M.R. Civ. P. 41(a)(2); Minn. Mining & Mfg. Co. v. Barr Labs., Inc., 289 F.3d 775, 779, 784 (Fed. Cir. 2002); and (3) the court did not err in dismissing U.S. Bank's declaratory judgment action for failure to state a claim upon which relief could be granted, see M.R. Civ. P. 12(b)(6); Beal Bank USA v. New Century Mortg. Corp., 2019 ME 150, ¶¶ 9-15, 217 A.3d 731; Meridian Med. Sys., LLC v. Epix *Therapeutics, Inc.,* 2021 ME 24, ¶ 2, 250 A.3d 122; *U.S. Bank Tr., N.A. v. Mackenzie*, 2016 ME 149, ¶ 11, 149 A.3d 267.
