MEMORANDUM OF DECISION

Ricky Sirois appeals from the denial of his motion to establish a payment schedule for his fines by the Superior Court (Kennebec County, *Marden, J.*). Contrary to Sirois's contentions, the chief administrative officer of the Maine State Prison is authorized to withdraw twenty-five percent of his income pursuant to 17-A M.R.S.A. § 1330(2) (Supp. 2001). Section 1330(2) was amended in 1997 to include the withholding of inmate income to pay fines. P.L. 1997, ch. 358, § 2. Although the section was again amended in 1999, it is clearly applicable to Sirois. P.L. 1999, ch. 469, § 3.
