MEMORANDUM OF DECISION

Lubomir Konecny appeals from a judgment of conviction in the Superior Court (Lincoln County, *Atwood, J.*), finding him guilty of operating with a suspended license, Class E, in violation of 29-A M.R.S.A. § 2412-A(1) (1996 & Supp. 2003). Contrary to Konecny's assertion, the State presented sufficient evidence at the trial. *See State v. McCurdy*, 2002 ME 66, ¶ 10, 795 A.2d 84, 88. Additionally, the court did not improperly rely on evidence of collateral issues because the allegedly irrelevant statements were relevant to Konecny's credibility.
