MEMORANDUM OF DECISION

Aaron M. Famosi appeals from an amended judgment entered by the District Court (Portland, Goranites, J.) upon the parties' post-judgment motions in the parental rights and responsibilities case Famosi brought against Erin L. Gonzales. Contrary to Famosi's contentions, (1) the court did not err in making an upward deviation in child support to account for Gonzales's travel expenses, see 19-A M.R.S. § 2007(3)(E), (J) (2007); Webb v. Webb, 2005 ME 91, ¶ 6, 878 A.2d 522, 525; (2) the court was not required to find that the parties provide substantially equal care for their child, 19-A M.R.S. §§ 2001(8), (8-A), 2006(5)(D-1) (2007); Jabar v. Jabar, 2006 ME 74, ¶ 17, 899 A.2d 796, 800; Powell v. Powell, 645 A.2d 622, 623-24 (Me. 1994); (3) the court did not err in ordering Famosi to pay for health insurance selected by Gonzales, see Roberts v. Roberts, 1997 ME 138, ¶ 9, 697 A.2d 62, 65; Wood v. Wood, 407 A.2d 282, 288 (Me. 1979); (4) the court did not abuse its discretion in making Gonzales responsible for health insurance, *Coppola v. Coppola*, 2007 ME 147, ¶ 9, 938 A.2d 786, 790; (5) the court did not abuse its discretion in awarding Gonzales the dependency tax exemption, see id.; (6) the court did not err in dividing the guardian ad litem fees, 19-A M.R.S. § 1507(7) (2007); cf. Carter v. Carter, 2006 ME 68, ¶ 20, 900 A.2d 200, 204; and (7) the court considered all relevant factors in awarding attorney fees, see Gould v.

A-1 Auto, Inc., 2008 ME 65, ¶ 13, 945 A.2d 1225, 1229-30. We deny Gonzales's request for sanctions. *See* M.R. App. P. 13(f).
